#### Retail Crime Survey The State of Retail Crime in Canada

- Retail crime has escalated into a national crisis, impacting profitability, safety, and consumer trust
- Theft is becoming more violent—76% of retailers report increased aggression from shoplifters
  - **Organized Retail Crime (ORC) is growing**, exploiting weak enforcement and legal loopholes
  - **Retailers are pulling out of high-crime areas**, locking high-theft products, or reducing hours
  - Communities, jobs, and consumer safety continue to suffer







#### Retail Crime Survey Financial Impact – Shrink Has Doubled since 2018

- Shrinkage has **doubled in five years**, reaching **\$9 billion annually (1.5% of total sales**).
- Retailers are **investing in security**, but **costs are unsustainable** without stronger enforcement.

## Retail Crime Survey Organized Retail Crime – A Growing Threat

ORC groups use **sophisticated tactics**, including:

- Cyber-facilitated fraud (reselling stolen goods online)
- Return fraud (manipulating return policies)
- Flash mob thefts (coordinated looting events)

Top cities impacted: Toronto, Mississauga, and Vancouver

121 weapons seized in RCC-led retail blitz operations in 2024

#### Retail Crime Survey Canada's Legal System is Falling Behind

- **Repeat offenders account for 17.7% of arrests** many are arrested and released the same day
- **Crown prosecutors often decline charges**, frustrating retailers and law enforcement

Judges hesitate to convict, even with strong evidence

Lack of a national crime reporting standard weakens advocacy and enforcement







#### Retail Crime Survey Retailers Are Fighting Back, But Need Support

**41.7% of retailers increasing budgets** for Al surveillance, inventory tracking, and facial recognition

Many are rethinking store layouts, staffing, and security measures, but solutions are costly

**Retailers need government action** to address ORC, legal loopholes, and weak penalties

#### Retail Crime Survey What Needs to Happen Now

- Make crime prevention a C-Suite priority Align security investments with growing threats
- **Demand legal reform** Support a national **Organized Retail Crime Act** with stronger penalties
  - **Standardize crime tracking** A national model will improve enforcement and advocacy
  - **Strengthen public-private collaboration** Law enforcement and policymakers must treat retail crime as an urgent issue
